Every Nurse Matters: A Peer-to-Peer Suicide Prevention Program

A team of nurse educators across the system collaborated with a local school of nursing's psychiatric nurse practitioner faculty to develop educational content based upon the Kentucky Board of Nursing suicide prevention continuing education requirement and the feedback from the nursing needs assessment.
