The Discover Card Settlement has officially been approved, and the filing deadline is set for May 18,

This settlement addresses allegations that Discover misclassified certain consumer credit card transactions as commercial between January 1, 2007, and December 31, 2023-resulting in potentially inflated interchange fees for End Merchants, Acquirers, and Payment Intermediaries.
